AN ACT concerning

The 2022-2023 Capital Budget CC205500 Bikeways & Pedestrian Access

FOR the purpose of amending the 2022-2023 Capital Budget, by appropriating to the Capital Budget Monies derived from federal funds and made available to the County from the Maryland Department of Transportation.

WHEREAS, in accordance with Section 716 of the Baltimore County Charter, the County Council may, upon recommendation of the County Executive, amend the Capital Budget; and

WHEREAS, the Maryland Department of Transportation has awarded federal funds to the Baltimore County Department of Public Works and Transportation, to be used to fund the construction of new raised crosswalks at nine intersections of the Torrey C. Brown Trail at Sparks Road, Corbett Road, Hicks Road, Hunters Mill Road, Graystone Road, Wiseburg Road, Dairy Road, Walker Road, and Freeland Road; now therefore

2023, be it hereby amended by appropriating federal funds in the in the amount herein specified,
