A BILL

AN ACT concerning

The 2022-2023 Current Expense Budget  
Gifts and Grants Special Revenue Fund

FOR the purpose of amending the 2022-2023 Current Expense Budget, by appropriating to the  
Gifts and Grants Special Revenue Fund monies derived from federal funds and made  
available to the County through the Maryland Department of Housing and Community  
Development for the purpose of assisting certain eligible Afghan refugee populations,  
should such a need arise in Baltimore County.

WHEREAS, Maryland DHCD has or will receive federal funding from the U.S.  
Department of Health and Human Services (“DHHS”) pursuant to the Additional Afghanistan

Supplemental Appropriations Act, 2022 (“ASA”) and any regulations or guidance promulgated thereunder (the “ASA Regulations”), of which a certain amount has been allocated to the Baltimore County Department of Housing and Community Development in response to the potential need to assist eligible Afghan refugees with housing-related services; and

WHEREAS, in accordance with Sections 306 and 712 of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2015, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections 306 and 712 of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2015, as amended, that the Current Expense Budget for the fiscal year ending June 30, 2023, be and is hereby amended by appropriating state funds derived from federal funds, and made available to the Baltimore County Department of Housing and Community Development, in the amount herein specified, to the following program:
