- FOR the purpose of permitting ground floor apartments in the Business, Major Commercial, Town-Center Core (B.M.-C.T.) under certain circumstances; and generally relating to uses permitted in the B.M.-C.T. Zone.
- BY repealing and re-enacting, with amendments

Section 235B.1

- SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
- 2 COUNTY, MARYLAND, that the Baltimore County Zoning Regulations read as follows:

1	ARTICLE 2 - ELEVATOR-APARTMENT RESIDENCE ZONES,
2	RESIDENTIAL-OFFICE ZONES, OFFICE ZONES, BUSINESS ZONES,

4	Section 235B – Special Regulations for C.T. Districts

6	§ 235B.1. Apartments; elderly housing facilities.
7	Apartments shall be permitted, but only above the first story of a building, except that
8	apartments and elderly housing facilities shall be permitted in any story of the building in
9	accordance with the following:
10	A. In the B.M. or B.MC.T. Zone located North of Shawan Road, West of York
11	Road, and South and East of McCormick Road within a Commercial Mixed Use Focal Point in
12	the Hunt Valley/Timonium Master Plan.
13	B. In the B.MC.T. Zone located north of Lakeside Boulevard, west of Painters
14	Mill Road, south of I-795/Northwest Expressway, and east of Owings Mills Boulevard in the
15	Owings Mills Town Center Sub Area of the Owings Mills Growth Area in the Master Plan 2020
16	C. IN THE B.MC.T. ZONE LOCATED NORTH AND WEST OF HONEYGO
17	BOULEVARD, SOUTH OF WHITE MARSH BOULEVARD, AND EAST OF PERRY HALL
18	BOULEVARD WITHIN THE WHITE MARSH MALL SUB AREA OF THE MIDDLE RIVER
19	REDEVELOPMENT AREA IN MASTER PLAN 2020.

21	SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by
22	the affirmative vote of five members of the County Council, shall take effect on March 21, 2022.
