



As Amended

WHEREAS, the County Council enacted Bill 92-89 effective February 9, 1993 which provided for a property tax credit for properties under certain circumstances that are in close proximity to a landfill; and

WHEREAS, Bill 92-89 provided that the County Council shall determine by law the properties adversely impacted by their proximity to the landfill; and

WHEREAS, on February 16, 2010, the County Council enacted Bill 10-02, which increased the boundaries to within 1,000 feet of a refuse disposal system; and

WHEREAS, ~~32~~ 36 applications were submitted and reviewed for compliance with the provisions of these Bills; and

WHEREAS, it was determined that these ~~32~~ 36 properties meet the parameters of Bill Nos. 92-89 and 10-02.

NOW THEREFORE,

Section 1. Be It Enacted By the County Council of Harford County that the following real properties receive a tax credit for the tax year that shall begin on July 1, 2023:


