ZONING BILL

1 AN ORDINANCE concerning

2 Tobacco shops, electronic cigarette shops or a retail tobacco business

13 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,

14 Maryland, sitting as the District Council for that part of the Maryland-Washington Regional

15 District in Prince George's County, Maryland, that Sections 27-2500 and 27-5402, being also

16 Subtitle 27 of the Prince George's County Code, be and the same are hereby repealed and

17 reenacted with amendments:

SUBTITLE 27. ZONING.

PART 27-1. GENERAL PROVISIONS.

20 **Sec. 27-1704. Transitional Provisions.**

* * * * *

(m) Notwithstanding the provisions specified within this section, no tobacco shop, electronic cigarette shop, or retail tobacco business that sells tobacco or electronic cigarette products for offsite use may be approved if it is located within a five-mile radius of another tobacco shop, electronic cigarette shop, or retail tobacco business that also sells tobacco or electronic cigarette products for offsite use.

PART 27-2. INTERPRETATIONS AND DEFINITIONS.

Sec. 27-2500. Definitions

Tobacco shop, electronic cigarette shop, or retail tobacco business

A retail store where the primary use is the retail sale of tobacco products, tobacco smoking accessories, any device that can be used to deliver nicotine or other substances to the person inhaling from the device, or any cartridge, component, or accessory of the device, and which may include on site consumption in accordance with Section 19-131 of the County Code and the incidental sale of food or beverage provided the gross floor area of the food or beverage area does not exceed 49 percent of the gross floor area.

PART 27-5. USE REGULATIONS.

27-5402. Additional Requirements for Specific Special Exception Uses

(kkk) Tobacco shops, electronic cigarette shops or a retail tobacco business.

(1) Tobacco shops, electronic cigarette shops, or a retail tobacco business may be permitted by special exception, subject to the following:

(A) The structure in which the use is proposed shall be located at least three hundred (300) feet from any school, library, park, recreational facility, and historic site, resource, or district identified on any applicable Historic Sites and District Plan, a National Register Site, or an Historic District. This provision shall not apply to a retail tobacco or electronic cigarette business within a recreational or entertainment establishment of a commercial nature with video lottery facility uses in accordance with Section 27-5102(e)(7)(D), Recreational or Entertainment Establishment of a Commercial Nature with a Video Lottery Facility, of this Subtitle.

(B) In its final decision to approve a special exception for the use, the Council may impose other reasonable requirements deemed necessary to safeguard the health, safety, morals, and general welfare of the community, taking into account the character of surrounding properties and the general neighborhood, and any other uses on the subject property.

1 (C) No special exception shall be permitted for a tobacco shop, electronic cigarette shop,
2 or a retail tobacco business located within 2,000 feet of another tobacco shop, electronic cigarette
3 shop, or a retail tobacco business.

4 (D) No special exception shall be permitted for a tobacco shop, electronic cigarette
5 shop or retail tobacco business that sells tobacco or electronic cigarette products for offsite use if
6 it is located within a 5-mile radius from another tobacco shop, electronic cigarette shop or retail
7 tobacco business that sells tobacco or electronic cigarette products for offsite use, measured from
8 property line to property line.

9 SECTION 2. BE IT FURTHER ENACTED that this Ordinance shall take effect take effect
10 forty-five (45) calendar days after its adoption.
