AN ACT to amend Chapter 18 of the Wicomico County Code, titled "Compensation and Allowance Commission", Section 3 titled "Compensation for County Council members", to provide for the compensation of members of the Wicomico County Council.

WHEREAS, the County Council of Wicomico County has heretofore received the report of the County Council Compensation and Allowance Commission for Wicomico County, dated December 21, 2021, as provided for in Chapter 18 of the Wicomico County Code, and, as a result of said report, deems it advisable to adjust the compensation to be paid to the members of the Wicomico County Council, commencing with the County Council elected in 2022;

SECTION I: BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEIGSLATIVE SESSION, that Chapter 18, Section 3 of the Wicomico County Code titled "Compensation for County Council members" be and the same is hereby amended to read as follows:

## CHAPTER 18

### Compensation and Allowance Commission

\* \* \*

#### § 18-3 Compensation for County Council members.

Commencing with the installation of the County Council elected at the general election in November of ~~1994~~ 2022, compensation to be paid to the members of the Wicomico County Council will be ~~(\$16,000)~~ TWENTY-ONE THOUSAND DOLLARS (\$21,000) a year to each member of the Council; ~~(\$17,000.00)~~ TWENTY-THREE THOUSAND DOLLARS (\$23,000) a year to the Vice-President of the Council while serving in that capacity; and ~~(\$18,000.00)~~ TWENTY-FIVE THOUSAND DOLLARS (\$25,000) a year to the President of said Council while serving in that capacity. In addition to the above compensation, each member shall receive allowances for traveling and any other necessary expenses actually incurred in the exercise of his official duties. Such allowances for traveling and any other necessary expenses incurred by the members of the Wicomico County Council in the exercise of their official duties shall be provided for in the annual operating budget of Wicomico County.

SECTION II: BE IT FURTHER ENACTED THAT this Bill shall be known as Bill No. 2022-01 of Wicomico County, Maryland and shall take effect sixty (60) days after its final passage, unless a proper Petition for Referendum thereof shall be filed prior to said date, in which event, the Bill shall not take effect until the expiration of thirty (30) days following the approval of this Bill by a majority of the qualified voters of the County voting in any such referendum.

Introduced and read first time on February 1, 2022. Ordered posted and public hearing scheduled for March 1, 2022 at 6:00 p.m.




