AN ACT concerning

Personnel Law of Baltimore County

- FOR the purpose of providing for certain changes to the Baltimore County Classification and Compensation Plans by amending certain Pay Schedules; changing certain pay grades; providing for the effective date of this Act; and generally relating to the governance and compensation of the personnel of Baltimore County Government.
- BY repealing and re-enacting, with amendments Pay Schedules VI-P, VII, and VIII Section I, Pay Schedules
- BY repealing and re-enacting, with amendments Certain pay grades Section II, Classifications and Grades

- SECTION 6. AND BE IT FURTHER ENACTED that this Act, having passed by the affirmative vote of five members of the County Council, shall take effect on July 3, 2023 and apply retroactively to July 1, 2023.
