Volunteer Fire Length of Service and Award Program – Minimum Benefit Payments

FOR the purpose of increasing the minimum benefit to a qualifying active volunteer member of a county volunteer fire, ambulance, rehabilitation, or rescue company under certain circumstances; and generally relating to the Volunteer Fire Length of Service and Award Program.

7	§ 14-4-101. Definitions.				
8	(a) In this title the following words have the meanings indicated.				
9	(b) "Association" means the Baltimore County Volunteer Firemen's Association.				
10	(c) "Member" means an active volunteer member of a county volunteer fire, ambulance,				
11	rehabilitation, or rescue company.				
12	(d) "Program" means the volunteer fire length of service award program.

14	§ 14-4-102. Established.				
15	There is a volunteer fire length of service award program for qualified active members of				
16	the county volunteer fire, ambulance, rehabilitation, and rescue companies that are active				
17	member companies of the association in good standing.				
18					
19	§ 14-4-106. Funding and Benefits.				
20	(a) Each year, the association shall submit to the Fire Chief the names of members who				
21	are eligible to receive benefit payments, specifying the number of months for which each will be				
22	eligible for benefit payments during that year.				
23	(b) Each year, the Fire Department shall submit with its budget a request for funds to pay				

I	to the association an amount sufficient to:
2	(1) Pay those members who are eligible or will become eligible to receive benefit
3	payments under the program; and
4	(2) Provide for the administration of the program.
5	(c) A member eligible to receive benefit payments under the program shall receive a
6	payment of at least [\$100] \$300 per month for life.
7	(d) (1) The County Executive periodically shall review the benefits of the program
8	and may recommend a change in the benefits.
9	(2) Revised benefits shall be effective on the first pay period in the new fiscal
10	year.

12	SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by
13	the affirmative vote of five members of the County Council, shall take effect 14 days from the
14	date of enactment.
