AN ACT TO AMEND CHAPTER 141 OF THE WICOMICO COUNTY CODE, TITLED "FEES," SECTION 141-3, TITLED "DEPARTMENT OF PLANNING, ZONING AND COMMUNITY DEVELOPMENT."

WHEREAS, Chapter 174 of the County Code now provides for nuisance enforcement fees; and

WHEREAS, the County Council desires to establish an administrative fee and penalty for repeat offenders of the nuisance code violations.

SECTION I. BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that Chapter 141 of The Wicomico County Code, Titled "Fees," Section 141-3, Titled "Department Of Planning, Zoning And Community Development" are hereby amended, to read as follows:

Chapter 141

Fees

* * *

§141-3 Department of Planning, Zoning and Community Development.

A. Fees enumerated. The following fees shall be collected by the Department of Planning, Zoning and Community Development:

- (B) Fees enumerated. The following fees shall be collected by the Code Enforcement Division.
 - (1) Abandoned vehicle permits: \$100.
 - (2) NUISANCE ENFORCEMENT FEES
 - A. ADMINISTRATIVE FEE FOR REPETITIVE OCCURRENCE: \$100 PER OCCURANCE

SECTION II: BE IT FURTHER ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION THAT this bill shall be known as Legislative Bill No. 2023-13 and shall take effect sixty (60) days after its enactment, unless a proper Petition for Referendum thereof shall be filed prior to said date; in which event, the Bill shall not take effect until the expiration of thirty (30) days following the approval of this Bill by a majority of the qualified voters of the County voting in any such referendum.
