1	The County Council of Frederick County, Maryland, finds it necessary and appropriate to				
2	amend Chapter 1-2 of the Frederick County Code to amend certain provisions related to				
3	membership on the Sustainable Monocacy Commission.

7	amended as shown on the attached Exhibit 1.

1 ARTICLE XIII: SUSTAINABLE MONOCACY COMMISSION 2 § 1-2-300. CREATION, PURPOSE. 3 There shall be a Frederick County Sustainable Monocacy Commission (SMC). (A) 4 (B) Among its duties, the SMC shall: 5 Recommend policies that improve water quality, maintain and restore the 6 ecological health and productivity of the Monocacy River and its tributaries, and conserve and 7 protect wildlife habitat, the natural, cultural, and scenic character of the Monocacy River and its 8 tributaries flowing in and through Frederick County. 9 Review studies, policies, and rules formulated by federal, state, and local (2) 10 government agencies that concern or affect the Monocacy River and its tributaries, and to 11 comment and provide advice on such proposals as appropriate. 12 Review and make recommendations on federal, state, county, and local 13 programs, policies, regulations, and public and private projects, which the SMC believes may 14 have an impact on the Monocacy River and its tributaries. 15 Review and make recommendations concerning the implementation of the **(4)** 16 most recent Frederick County approved Monocacy Scenic River Management Plan and to help 17 fulfill the other objectives as outlined in the document. 18 Educate the public and increase awareness about the importance of the 19 Monocacy River's environmental, cultural, and recreational resources, and provide information 20 related to actions that can be taken by individuals and communities to reduce pollution, conserve 21 water, and promote a healthy and productive Monocacy River and its tributaries. 22 Prepare a written report outlining the activities, goals, and (6) 23 accomplishments of the SMC annually or as appropriate. This report shall be submitted to the 24 County Executive and County Council, and posted on the SMC website.

27	(A)	The term	of office of each of the members shall be for a period of four years,	
28	based on the	County's f	iscal year, July 1 to June 30. The terms of the members shall be staggered	
29	so that no mo	ore than fiv	e members are replaced each year.	

1	(B) Of the initial 11 members, five shall be appointed for a four-year term; and four				
2	shall be appointed for a three-year term; and two shall be appointed for a two-year term.]				
3	[(C)](B) Members may be <u>reappointed but</u> may not serve more than two full				
4	consecutive four-year terms.				
5	[(D)] (C) Vacancies shall be filled on the same basis as the original appointments for the				
6	unexpired terms. Members shall continue in office until their successors are appointed and				
7	qualified.

9	§ 1-2-303. CHAIR, VICE-CHAIR.				
10	The Chair and Vice-Chair will be selected by the members of the SMC.				
11					
12	§ 1-2-304. MEETINGS AND QUORUM.				
13	(A) The SMC shall meet as frequently as determined by the SMC, but not less than				
14	twice per calendar year. Meeting locations shall be determined by the SMC Chair and shall be in				
15	Frederick County, open to the public, and ADA accessible.				
16	(B) Notice of the date, time, and place of the SMC meetings shall meet the				
17	requirements of the Maryland Open Meetings Act.				
18	(C) A majority of the SMC voting members shall constitute a quorum for the				
19	transaction of regular business.				
20	(D) Any voting member of the SMC who fails to attend at least 50% of the meetings				
21	during any period of 24 consecutive months shall be considered to have resigned. Subject to				
22	confirmation by the County Council, the County Executive shall appoint a replacement.				
23					
24	§ 1-2-305. RULES AND REGULATIONS.				
25	The SMC shall adopt rules to govern its procedures and activities.				
26					
27	§ 1-2-306. COMPENSATION.				
28	Members of the SMC shall receive no compensation for their services.				

2	A county staff member will be designated by the County Executive as a liaison to assist
3	the SMC in its duties.
