PUBLIC HEARING

Having been posted and notice of time and place of hearing and title of Bill having been published according to the Charter, a public hearing was held on November 5, 2024, and concluded on, November 5, 2024.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW. [Brackets] indicate matter deleted from existing law. Underlining indicates language added to Bill by amendment. Language lined through indicates matter stricken out of Bill by amendment.

WHEREAS, the County Council enacted Bill 92-89 effective February 9, 1993 which provided for a property tax credit for properties under certain circumstances that are in close proximity to a landfill; and

WHEREAS, Bill 92-89 provided that the County Council shall determine by law the properties adversely impacted by their proximity to the landfill; and

WHEREAS, on February 16, 2010, the County Council enacted Bill 10-02, which increased the boundaries to within 1,000 feet of a refuse disposal system; and

WHEREAS, 35 applications were submitted and reviewed for compliance with the provisions of these Bills; and

WHEREAS, it was determined that these 35 properties meet the parameters of Bill Nos. 92-89 and 10-02.

NOW THEREFORE,

Section 1. Be It Enacted By the County Council of Harford County that the following real properties receive a tax credit for the tax year that shall begin on July 1, 2025:

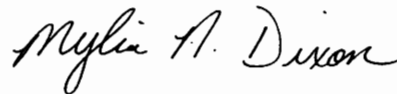
