10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
11 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

13 **ARTICLE 17. SUBDIVISION AND DEVELOPMENT**

14 **TITLE 2. GENERAL PROVISIONS**

15 **17-2-101. Scope; applicability.**
16

17 (a) **Scope.** This article applies to all land located in the County, except that it does not
18 apply to land owned or leased and developed by the County, ~~[[or]]~~ the Board of Education,
19 OR ~~PUBLIC CHARTER SCHOOLS FOR USE AS A PUBLIC CHARTER SCHOOL, AS DEFINED IN~~
20 § 9-102 OF THE EDUCATION ARTICLE OF THE STATE CODE, unless federal or State law
