A BILL ENTITLED

1 AN ORDINANCE concerning: Public Works – Solid Waste Collection – Solid Waste
2 Service Charge – Solid Waste Landfill and Facility Delivery Fees

4 FOR the purpose of modifying the solid waste service charge; modifying certain charges
5 for delivery of solid waste to a landfill or waste disposal facility; providing for the
6 effective date of this Ordinance; and generally relating to public works.

8 BY repealing and reenacting, with amendments: § 13-4-105(b)
9 Anne Arundel County Code (2005, as amended)

11 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
12 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

13 ARTICLE 13. PUBLIC WORKS

14 TITLE 4. SOLID WASTE COLLECTION

15 13-4-105. Solid waste service charge.

18 (b) **Amount.** There is a service charge in the amount of ~~[\$404]~~ \$426.00 per fiscal year.
19 For the fiscal year beginning July 1, ~~[[2025]]~~ 2026, and for each fiscal year thereafter, the
20 County Executive shall set the service charge for County curbside collection service and
21 may increase the charge in an amount not to exceed 5.00% of the then current charge. Any
22 increase greater than 5.00% shall be set by the County Council by ordinance. The service
23 charge shall be collected as provided in § 1-8-101 of this Code.
