10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
11 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

12 ARTICLE 18. ZONING

13 TITLE 10. REQUIREMENTS FOR CONDITIONAL USES

14 18-10-172. Waterman’s home commercial use.

17 A waterman’s home commercial use shall comply with all of the following
18 requirements.

21 (10) The onsite sale of seafood harvested by a resident is allowed by the resident only
22 during the hours of 9:00 a.m. to 6:00 p.m. Monday through ~~[[Friday]]~~ SATURDAY and 9:00
23 a.m. to 4:00 p.m. ~~[[Saturday and]]~~ Sunday.
