A BILL ENTITLED

1 AN ORDINANCE concerning: Public Campaign Financing – Disbursement of Public
2 Contribution – Funding for Public Campaign Financing Fund

4 FOR the purpose of determining the deadline to file a notice of intent to participate in the
5 public campaign financing fund; aligning the ratio of amount and number of
6 contributions among County Executive and Council candidates; determining the
7 threshold for the Controller to certify sufficient fund balance; providing for a second
8 review of fund balance by the Controller during the election cycle; requiring the County
9 Executive to appropriate sufficient funds pursuant to the Charter; modifying the
10 required timeframe for disbursement of public contributions to the publicly funded
11 campaign account of the participating candidate; providing for limitations on public
12 contributions for uncontested elections; ~~providing for minimum appropriations~~
13 ~~beginning in Fiscal Year 2028~~; providing for staffing for the Commission; requiring
14 the designation of a public liaison for the public campaign financing system; requiring
15 an audit of the public campaign financing system after a general election; and generally
16 relating to public campaign financing.

SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
That the Anne Arundel County Code (2005, as amended) read as follows:

ARTICLE 1. GENERAL PROVISIONS

TITLE 12. PUBLIC CAMPAIGN FINANCING

1-12-103. Contributions.

(a) **Prerequisites.** Before raising any contribution governed by this title, an applicant candidate shall:

(1) File notice of intent with the Board on or before [[April 15 of the year of the election]] THE DEADLINE TO FILE A CERTIFICATE OF CANDIDACY AS DETERMINED BY §5-303(A)(1) OF THE ELECTION LAW ARTICLE OF STATE CODE on a form prescribed by the Board; and

(2) Establish a publicly funded campaign account for the purpose of receiving eligible contributions and spending funds in accordance with this title.

1-12-104. Requirements for certification.

(a) **Qualification.** To qualify as a certified candidate:

(1) An applicant candidate for County Executive shall collect from County residents at least:

(i) 500 qualifying contributions; and

(ii) an aggregate total of \$40,000 FOR THE 2026 ELECTION CYCLE OR \$50,000 FOR EVERY ELECTION CYCLE THEREAFTER; and

(2) An applicant candidate for Councilmember shall collect from County residents at least:

(i) 75 qualifying contributions; and

(ii) an aggregate total of \$7,500.

1-12-106. Disbursements of public contribution.

(d) **Review of Fund balance.** (1) On or before July 1 of the year preceding a primary election, the Controller shall determine if the amount in the Fund is sufficient to meet the maximum public contributions ~~THE GREATER OF THE~~ AMOUNT REASONABLY EXPECTED TO BE REQUIRED DURING THE NEXT ELECTION CYCLE BASED ON INTEREST EXPRESSED BY CANDIDATES OR TO FUND AT LEAST ONE CERTIFIED CANDIDATE FOR COUNTY EXECUTIVE

1 ~~AND FOUR CERTIFIED CANDIDATES FOR COUNTY COUNCIL CANDIDATES WHO HAVE~~
2 ~~INDICATED TO THE MARYLAND STATE BOARD OF ELECTIONS THAT THEY WILL SEEK~~

13 ~~(3)~~ (2) If UPON REVIEW UNDER ~~(1) OR (2)~~ PARAGRAPH (D)(1), the Controller
14 determines that the total amount available for disbursement in the Fund is insufficient to
15 meet the allocations required by this section, the Controller shall reduce each public
16 contribution to a certified candidate based on the ratio of the amount in the Fund to the
17 maximum public contributions reasonably expected to be required. IF FUNDING IS
18 SUPPLEMENTED THE CONTROLLER SHALL RESTORE EACH PUBLIC CONTRIBUTION TO A
19 CERTIFIED CANDIDATE THAT WAS PREVIOUSLY REDUCED.

21 ~~(4)~~ (3) IF THE CONTROLLER DETERMINES AT ANY POINT AFTER JULY 1 OF THE YEAR
22 PRECEDING A GENERAL ELECTION THAT THE TOTAL AMOUNT AVAILABLE FOR
23 DISBURSEMENT IN THE FUND IS INSUFFICIENT TO MEET THE MAXIMUM PUBLIC
24 CONTRIBUTIONS REASONABLY EXPECTED TO BE REQUIRED FOR ALL CANDIDATES
25 CERTIFIED IN THE CURRENT ELECTION CYCLE, THE CONTROLLER SHALL NOTIFY THE
26 COUNTY EXECUTIVE, THE COUNTY COUNCIL AND THE BOARD WITHIN 3 DAYS OF THE
27 DETERMINATION. THE CONTROLLER MAY SHALL INCLUDE IN THE NOTIFICATION AN
28 ESTIMATED AMOUNT NEEDED TO COMPLETE THE ELECTION CYCLE BASED ON THE
29 NUMBER OF CERTIFIED CANDIDATES, THE DISBURSEMENTS COMPLETED UP TO THE TIME
30 OF THE NOTIFICATION, AND THE AMOUNT OF TIME REMAINING IN THE ELECTION CYCLE
31 AND THE DISBURSEMENT PERIOD. EXCEPT UNDER THE LIMITATIONS OF §1-12-111, THE
32 COUNTY EXECUTIVE SHALL SUBMIT A REQUEST FOR THE AMOUNT OF FUNDS THE
33 CONTROLLER DETERMINES NECESSARY TO COMPLETE THE ELECTION CYCLE TO THE
34 COUNTY COUNCIL TO SUPPLEMENT THE FUND BY A TRANSFER OR SUPPLEMENTARY
35 APPROPRIATION PURSUANT TO SECTIONS 711 OR 712 OF THE COUNTY CHARTER WITHIN 5
36 DAYS. THE COUNCIL MAY CONSIDER THE REQUEST TO SUPPLEMENT THE FUND AS AN
37 EMERGENCY ORDINANCE.

41 (g) Proof of qualifying contributions. A participating candidate shall submit a receipt
42 for each qualifying contribution to the Board to receive a public contribution. The
43 Controller shall disburse the appropriate public contribution into a participating candidate's
44 publicly funded campaign account [[within three business days after the Board authorizes
45 the public contribution]] PROMPTLY BUT NO LATER THAN 10 BUSINESS DAYS AFTER
46 RECEIVING THE PARTICIPATING CANDIDATE'S SUBMISSION.

50 (K) Uncontested elections. A CERTIFIED CANDIDATE IN AN UNCONTESTED ELECTION
51 SHALL RECEIVE ONE-THIRD OF THE PUBLIC CONTRIBUTION AMOUNT THE CERTIFIED
52 CANDIDATE WOULD OTHERWISE BE ENTITLED TO RECEIVE.

1-12-111. Funding for the Public Campaign Financing Fund.

(a) **Annual funding.** Except as provided in subsection (b) ~~it, it;~~

~~(4)~~ in each fiscal year, the County Executive shall include in the annual budget and appropriation ordinance the amount calculated by the Public Campaign Financing System Commission as necessary to fully fund the public campaign financing system for the fiscal year.

~~(2) BEGINNING IN FISCAL YEAR 2028 AND FOR EVERY FISCAL YEAR THEREAFTER, THE COUNTY EXECUTIVE SHALL INCLUDE THE GREATER OF \$300,000 OR THE AMOUNT CALCULATED BY THE PUBLIC CAMPAIGN FINANCING SYSTEM COMMISSION IN THE ANNUAL BUDGET AND APPROPRIATION ORDINANCE.~~

(b) **Exception.** The County Executive is not required to include the amount calculated by the Public Campaign Financing System Commission as necessary to fully fund the public campaign financing system for the fiscal year in the annual budget and appropriation ordinance if:

(1) in the current fiscal year, funds have been or are being transferred from the Revenue Reserve Fund to the General Fund pursuant to § 4-11-106 of this Code; or

(2) not later than 120 days prior to the end of the fiscal year, the County Executive certifies to the County Council that the County's fiscal condition makes it imprudent to include the full amount calculated by the Public Campaign Financing System Commission as necessary to fully fund the public campaign financing system for the fiscal year, and the County Council approves the certification by a vote of not less than five members.

(c) **Public Campaign Financing Fund.** Funds to finance the public campaign financing system included in the annual budget and appropriation ordinance shall be included in and disbursed from the Public Campaign Financing Fund.

(d) **Staffing.** THE BUDGET OFFICER SHALL PROVIDE THE COMMISSION WITH INFORMATION REGARDING ECONOMIC TRENDS AND THE COUNTY'S FISCAL PLANS IN RELATION TO THE PUBLIC CAMPAIGN FINANCING SYSTEM. The County Executive ~~[[may]]~~ SHALL provide staff support for the Commission AND DESIGNATE A PUBLIC LIAISON TO PROVIDE INFORMATION ON THE SYSTEM TO CANDIDATES AND THE PUBLIC.

(E) **Additional Appropriations.** THE COUNTY EXECUTIVE MAY PROPOSE A TRANSFER OR SUPPLEMENTARY APPROPRIATION BY ORDINANCE UP TO THE AMOUNT RECOMMENDED BY THE PUBLIC CAMPAIGN FINANCE SYSTEM COMMISSION UNDER §1-12-110(D) AT ANY TIME DURING THE FISCAL YEAR. PURSUANT TO §1-12-106(D), THE COUNTY EXECUTIVE SHALL SUPPLEMENT THE FUND BY A TRANSFER OR SUPPLEMENTARY APPROPRIATION PURSUANT TO SECTIONS 711 OR 712 OF THE COUNTY CHARTER.

1-12-113. Audit.

(A) **In general.** BEGINNING 60 DAYS AFTER THE BOARD CERTIFIES THE RESULTS OF THE GENERAL ELECTION, THE COUNTY AUDITOR SHALL CONDUCT AN AUDIT OF THE FINANCIAL ACTIVITY OF THE PUBLIC CAMPAIGN FINANCING SYSTEM, INCLUDING

PUBLICLY FUNDED CAMPAIGN ACCOUNTS, TO ENSURE PUBLICLY FUNDED CAMPAIGN ACCOUNTS RAISED AND SPENT FUNDS IN COMPLIANCE WITH THIS TITLE.

(B) Scope.

(1) THE AUDIT SHALL APPLY TO THE CAMPAIGN ACCOUNTS OF ALL CANDIDATES WHO:

(I) FILED AN INTENT TO PARTICIPATE IN THE PUBLIC CAMPAIGN FINANCING SYSTEM; AND

(II) FILED FOR CERTIFICATION TO BECOME QUALIFIED CERTIFIED CANDIDATES.

(2) THE AUDIT SHALL INCLUDE A REVIEW OF:

(I) ELIGIBLE CONTRIBUTIONS;

(II) QUALIFYING CONTRIBUTIONS;

(III) CAMPAIGN EXPENDITURES;

(IV) DISTRIBUTIONS OF PUBLIC CONTRIBUTIONS;

(V) THE CERTIFIED CANDIDATES BOARD CERTIFICATION REPORT; AND

(VI) CANDIDATE APPLICATIONS FOR CERTIFICATION THAT WERE NOT APPROVED BY THE BOARD.

(3) THE AUDIT SHALL VERIFY THAT PARTICIPATING CANDIDATES RETURNED:

(I) ANY UNSPENT FUNDS FROM THE PUBLICLY FUNDED CAMPAIGN ACCOUNT TO THE CONTROLLER FOR DEPOSIT INTO THE FUND IN ACCORDANCE WITH §1-12-107(D);

(II) ANY FUNDS MISTAKENLY DISBURSED FROM THE PUBLICLY FUNDED CAMPAIGN ACCOUNT TO THE CONTROLLER FOR DEPOSIT INTO THE FUND IN ACCORDANCE WITH §1-12-106(J); AND

(III) ANY UNSPENT FUNDS FROM THE PUBLICLY FUNDED CAMPAIGN UPON THE WITHDRAWAL FROM THE ELECTION TO THE CONTROLLER FOR DEPOSIT INTO THE FUND IN ACCORDANCE WITH §1-12-108(B).

(C) Records and responses. CANDIDATES SHALL COMPLY WITH ALL REQUESTS FOR INFORMATION AND DOCUMENTATION FROM THE AUDITOR DURING THE AUDIT PROCESS.

(D) Findings. THE RESULTS AND FINDINGS OF THE AUDIT SHALL BE SENT TO THE COUNTY EXECUTIVE, THE COUNTY COUNCIL, THE COMMISSION AND THE BOARD AT THE CONCLUSION OF THE AUDIT. CANDIDATES MAY RESPOND TO OR CONTEST AUDIT FINDINGS WITHIN 30 DAYS OF THE CONCLUSION OF THE AUDIT.

SECTION 2. *And be it further enacted,* That this Ordinance shall take effect 45 days from the date it becomes law.
