4 FOR the purpose of increasing the duration of the 9-1-1 specialist property tax credit; and

10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
11 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

14 TITLE 2. REAL PROPERTY TAXES

15 SUBTITLE 3. CREDITS

16 4-2-301. 9-1-1 specialist property tax credit.

19 (e) **Duration.** The tax credit shall be available to a 9-1-1 specialist eligible under
20 subsection (c) for a period of one taxable year and may be renewed upon application of the
21 9-1-1 specialist for ~~four~~ NINE additional taxable years, for a maximum total of ~~five~~
22 TEN taxable years.
