A BILL
ENTITLED

AN ACT concerning

Zoning Regulations – Farm Markets – Accessory Carry-Out Restaurant

FOR the purpose of permitting a carry-out restaurant as an accessory use to a farm market in the H District; establishing certain location, siting, and gross floor area restrictions for accessory carry-out restaurants; requiring an accessory carry-out restaurant to maintain the same hours of operation as the principal farm market; and generally relating to farm markets, carry-out restaurants, accessory uses, and uses permitted in the H District.

Section 404.4.E
Baltimore County Zoning Regulations, as amended

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, that the Baltimore County Zoning Regulations read as follows:

4 ARTICLE 4 – SPECIAL REGULATIONS

5 Section 404 – Farm and Agricultural Operations

7 § 404.4. Agricultural roadside businesses.

8 Agricultural roadside businesses are permitted, subject to the following requirements:

9 E. IN THE H DISTRICT, A CARRY-OUT RESTAURANT IS PERMITTED AS AN
10 ACCESSORY USE TO A FARM MARKET, PROVIDED THE CARRY-OUT
11 RESTAURANT:

12 1. IS LOCATED WITHIN THE SAME BUILDING AS THE FARM MARKET;

13 2. HAS THE SAME HOURS OF OPERATION AS THE FARM MARKET;

14 AND

15 3. DOES NOT:

16 A. EXCEED 25% OF THE GROSS FLOOR AREA OF THE FARM
17 MARKET; AND

18 B. SELL PRE-PACKAGED FOOD THAT WAS PREPARED OFF-
19 PREMISES.

21 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by
22 the affirmative vote of five members of the County Council, shall take effect 14 days from the
23 date of its enactment.
