A BILL
ENTITLED

AN ACT concerning

Zoning Regulations – Uses Permitted in the Manufacturing, Light (M.L.) Zone –
Automotive Enthusiast Club

FOR the purpose of defining an automotive enthusiast club; permitting by right an automotive enthusiast club under certain circumstances in the M.L. Zone; and generally relating to uses permitted in the M.L. Zone.

BY adding

Sections 101.1, the definition of “Automotive Enthusiast Club” listed alphabetically
and 253.1.A.62

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, that the Baltimore County Zoning Regulations read as follows:

4 ARTICLE 1 – GENERAL PROVISIONS

5 Section 101 – Definitions

7 § 101.1. Word usage; definitions.

8 Words used in the present tense include the future; words in the singular number include
9 the plural number; the word “shall” is mandatory. For the purposes of these regulations, certain
10 terms and words are defined below.

11 Any word or term not defined in this section shall have the ordinarily accepted definition
12 as set forth in the most recent edition of Webster’s Third New International Dictionary of the
13 English Language, Unabridged.

14 AUTOMOTIVE ENTHUSIAST CLUB – A FACILITY THAT OFFERS
15 AUTOMOTIVE STORAGE WITH ACCESS FOR MEMBERS AND THEIR GUESTS TO: A
16 PRIVATE RESTAURANT AND LOUNGE AREA THAT INCLUDES OUTDOOR SEATING;
17 PRESENTATIONS BY INDUSTRY EXPERTS; CLASSES ON ISSUES SUCH AS
18 AUTOMOBILE SAFETY AND MAINTENANCE; ADMINISTRATIVE OFFICES; AND
19 RELATED ACCESSORY USES. RELATED ACCESSORY USE SHALL NOT INCLUDE A
20 RACING TRACK OR RACING FACILITY.

22 ARTICLE 2 – ELEVATOR-APARTMENT RESIDENCE ZONES,
23 RESIDENTIAL-OFFICE ZONES, OFFICE ZONES, BUSINESS ZONES,

1 MANUFACTURING ZONES AND DISTRICTS

2 Section 253 – Manufacturing, Light (M.L.) Zone Use Regulations

3
4 § 253.1. Uses permitted as of right.

5 The uses listed in this section, only, shall be permitted as of right in M.L. Zones, subject
6 to any conditions hereinafter prescribed.

7 A. The following industrial uses:

8 62. AUTOMOTIVE ENTHUSIAST CLUB, IF LOCATED EAST OF I-
9 83 AND OUTSIDE OF THE URBAN-RURAL DEMARCATION LINE.

11 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by
12 the affirmative vote of five members of the County Council, shall take effect 14 days after its
13 enactment.
