**VILLAGE COUNCIL OF SECTION 3
OF THE VILLAGE OF CHEVY CHASE
A RESOLUTION TO AMEND SECTION 703 OF THE CHARTER
OF SECTION 3 OF THE VILLAGE OF CHEVY CHASE**

This Resolution of the Council of Section 3 of the Village of Chevy Chase (the "Council") is adopted pursuant to the Constitution of Maryland, Article XI-E, the Maryland Code, Local Government Article, Section 4-301, et seq., and the Charter of Section 3 of the Village of Chevy Chase (the "Village Charter"), to amend Section 703 of the Village Charter to add exceptions to the competitive bidding requirements, regarding the procurement of professional services or services competitively bid by another governmental entity.

Section 1. BE IT RESOLVED BY THE VILLAGE COUNCIL, that Section 703 of the Village Charter be amended to read as follows:

Section [.] 703, **Contractual Authority**

The Council shall not contract for material or work, other than personal or professional service contracts, in a sum exceeding Ten Thousand Dollars (\$10,000.00) without having first invited bids for the same, after which the Council may purchase such material or contract for such work and have such work done by employed labor or otherwise as it deems best; provided however, that the foregoing shall not apply to contractual or other arrangements with Montgomery County, Maryland or the State of Maryland. No Council member shall sell supplies or services of any kind to Section 3 or contract in any manner with the Council.

Notwithstanding any other provision of this Charter to the contrary, the Council may contract for material or work without having first invited bids for the same if the contract award serves a public purpose and: (1) there is only one source for the required material or work which can meet the needs of Section 3; (2) the contact is in connection with potential or pending litigation, condemnation, or collective bargaining; (3) a proposed contractor or subcontractor has been specifically identified in a grant accepted by Section 3; (4) a proposed contractor or subcontractor has been selected through a competitive bidding process undertaken by another state, county, or municipality, or cooperatively with Section 3, and substantially similar terms are offered to Section 3; (5) the services are professional in nature, including but not limited to, accounting, architecture, auditing, engineering, legal, and surveying services; or [4] (6) there exists a threat to public health, safety, or welfare where delay would seriously injure Section 3 financially or otherwise.


(NOTE: Underlining indicates material added to the Charter; bold brackets [] indicate material deleted from the Charter)

Section 2. AND BE IT FURTHER RESOLVED, that following a duly noticed hearing, that the date of the adoption of this Resolution is July 14, ____ 2021, and that the amendment to the Village Charter hereby proposed by this enactment shall be and become effective on Sept 1, ____ 2021 (fifty (50) days from adoption), unless a proper petition for a referendum hereon shall be filed as permitted by law on or before Aug 22, ____ 2021 (forty (40) days from adoption).

Section 3. AND BE IT FURTHER RESOLVED, that a complete and exact copy of this Resolution shall be posted at _____, Chevy Chase, Maryland 20815 for at least forty (40) days following adoption and a fair summary of this Resolution shall be published in a newspaper of general circulation in Section 3 of the Village of Chevy Chase not less than four (4) times, at weekly intervals, within a period of at least forty (40) days starting immediately after the date of adoption.

Section 4. AND BE IT FURTHER RESOLVED, that as soon as the Charter Amendment hereby enacted shall become effective, either as herein provided or following a referendum, the Chair of the Village Council shall send, by certified mail, return receipt requested, bearing a postmark from the United States Postal Service, to the Department of Legislative Services, the following information concerning the Charter Amendment: (i) the complete text of this Amendment to the Village Charter as hereby enacted; (ii) the date of the referendum election, if any, held with respect thereto; (iii) the number of votes cast for and against the question concerning the Charter Amendment, whether by the Village Council or in a referendum; and (iv) the effective date of the Charter Amendment.

Section 5. AND BE IT FURTHER RESOLVED, that the said Chair be and is hereby specifically instructed to carry out the provisions of Sections 3 and 4. As evidence of compliance herewith, the said Chair shall cause to be placed in the Village files the following information concerning the Charter Amendment: (i) appropriate certificates of publication of the newspaper in which a fair summary of this Resolution shall have been published; and (ii) the return receipts of the mailing referred to in Section 4, and shall further complete and execute the Certificate of Effect attached hereto.


