

Budget Overview

Exhibit 1 shows the programmed level of funding for the two Historic St. Mary's City Commission (HSMCC) projects as programmed in the 2021 Capital Improvement Program (CIP) and compares this to what was programmed in last session's CIP. Overall, the scheduled timing of funding for the Maryland Heritage Interpretive Center is adjusted to reflect a delay in the start of construction, and the 2021 CIP includes a new multi-year effort to address site improvement projects beginning in fiscal 2026.

Maryland Heritage Interpretive Center

The Maryland Heritage Interpretive Center project will address several deficiencies with the existing center, including its remote location that separates it from other significant interpretive sites, and inadequate exhibit, office, storage, restroom, and interpretive space. The fiscal 2022 budget provides \$4.782 million in general obligation bond funds to continue the planning and begin the construction of the project. Additionally, the budget preauthorizes \$10.846 million for fiscal 2023 to complete the construction funding phase. The project previously received \$2.6 million to fund design and, the total project cost is estimated at \$19.1 million. As noted above, the start of construction is

expected later in fiscal 2022 than was programmed last year, resulting in a revised funding plan that moves more of the construction funds into fiscal 2023 and requiring less in fiscal 2022.

Summary of Other Projects in the Capital Improvement Program

Site Improvements

This project will fund several site development projects to improve the visitor experience. A preliminary list of projects includes the following:

- repair of a 1.2 acre parking lot;
- replacement of light fixtures in parking lot;
- repair of 1.5 miles of uneven and cracked paths and adding lighting;
- replacement of damaged water fountains; and
- repair of 3.5 miles of wooded hiking trails.

The CIP programs \$1 million in fiscal 2026 to start what is presumed to be a multi-year effort estimated to require \$4 million in State funding to complete. Because HSMCC projects are not scored high enough in the Department of General Services Facility Renewal Program scoring, the commission has had to rely on its limited operating budget, fundraising, and occasional authorizations added by the legislature to address the most critical facility renewal and site development projects. In as much as the commitment programmed by the State for this purpose is relatively small, the committees may wish to consider accelerating the start of this initiative.
