
#### **Program Description**

The Office of the State Prosecutor (OSP) is an independent agency within the Executive Branch that investigates and, where warranted, prosecutes criminal offenses affecting the honesty and integrity of governmental officials, institutions, and the electoral process. The State Prosecutor may investigate on his/her own initiative — or at the request of the Governor, the Attorney General, the General Assembly, the State Ethics Commission, or a State's Attorney — certain criminal offenses including election law and public ethics law violations; State bribery law violations involving public officials or employees; misconduct in office by public officials or employees; and extortion, perjury, or obstruction of justice related to any of the above.

In addition, the State Prosecutor may investigate and prosecute any offense that takes place in more than one county within the State or in more than one state including Maryland.

Fiscal 2023 Budget Increases \$62,495, or 3.5%, to \$1.8 Million (\$ in Thousands)





### Fiscal 2023 Overview of Agency Spending

As shown in **Exhibit 1**, approximately 85% of the OSP budget is personnel spending. Due to the nature of the work done by OSP, the personnel component touches nearly all aspects of the agency. This includes preliminary investigations, actual cases, and administrative work. Office supplies and information technology (IT) expenses (9%) comprise the next largest category of spending.

## **Proposed Budget Change**

The fiscal 2023 allowance for OSP increases by \$62,495, as shown in **Exhibit 2**. This increase is driven largely by personnel expenses and increases in IT spending.


## 1. Corruption Complaints and Election Referrals Increase, Corruption Conviction Rates Drop

OSP generally divides its cases into two main categories – Election Law and Corruption. OSP corruption cases do not follow any predictable pattern; however, election law cases grow and decline along with the current election cycle. Additionally, OSP has the jurisdiction to investigate cases of police misconduct within the State.

#### Corruption Cases Rise Dramatically in 2021 and 2022

As shown in **Exhibit 3**, all reported performance measures pertaining to corruption cases increased significantly in fiscal 2021 and 2022. In fiscal 2021, the number of complaints received grew by 41% over the prior year. The number of investigations opened grew dramatically by 166% between fiscal 2020 and 2021. Additionally, the number of cases closed and cases charged increased by 757% and 86%, respectively, during the same time period. OSP has expanded their cooperation with local, State, and federal law enforcement agencies. These partnerships have created more opportunities for joint operations with other agencies. Additionally, OSP states that there has been a significant increase in referrals due to this collaboration on cases of corruption and police misconduct. **OSP should comment on its work on investigations of police misconduct and how this work overlaps with the work of the Office of the Attorney General Independent Investigations Division.** 

Exhibit 3 Corruption Cases Fiscal 2018-2022 Est.



The number of election law referrals increased in fiscal 2021, while the number of enforcement actions taken decreased, as shown in **Exhibit 4.** In fiscal 2021, the number of referrals received grew by 41% over the prior year. The decline in enforcement actions taken reflected a 53% reduction between fiscal 2020 and 2021.

#### **Increased Pressure on OSP Personnel**

OSP is one of the smaller State agencies in terms of both budget (approximately \$1.8 million in fiscal 2023) and personnel (13 employees). However, it is involved in many investigations that have furthered the State's interests in terms of dealing with corruption and ensuring transparency with respect to government officials. In fiscal 2021, referrals and complaints received by the office have increased 604% and 132%, respectively, since fiscal 2018, several of which have been high-profile, time-intensive cases. Referrals and complaints that OSP receive must be evaluated to determine if there is a possible case, which requires staff to devote hours to each of these potential cases, in addition to the cases that proceed to open investigations or enforcement actions. **OSP should comment on the increase in referrals and complaints and the resulting impact on its personnel needs.** 

## **Operating Budget Recommended Actions**

1. Concur with Governor's allowance.
