

# **Key Observations**

- Capital Grants for Arts Organizations: Chapters 394 and 395 of 2021 established the Maryland Arts Capital Grant Program and mandated \$3 million of funding annually for fiscal 2024 through 2029. The program provides grant funding for capital projects to nonprofit arts and cultural organizations. In the first two years of operation, the program has awarded \$6 million to 27 organizations.
- Funding in the Out-years: The Capital Improvement Program (CIP) includes \$3 million annual funding through fiscal 2030.

## Budget Overview of Grant and Loan Programs

Chapters 394 and 395 established the Maryland Arts Capital Grant Program, administered by the Maryland State Arts Council (MSAC) in the Department of Commerce (Commerce). From fiscal 2024 through 2029, the Governor must include \$3.0 million in the State operating or capital budget for the program. This mandate is met with general obligation (GO) bonds in fiscal 2026, and the CIP also plans \$3.0 million in GO bonds annually through the end of the planning period in fiscal 2030.

MSAC must award grants to organizations with an operating budget under \$3.0 million that participate in the council's Grants for Organizations Program or Community Arts Development Program or are open to the public and provide cultural education or experiences. Per Chapters 394 and 395, a grant may be awarded for the acquisition of, expansion of, renovation of, or major repairs to a facility or other infrastructure that is operated by an eligible recipient. Under the statute, an organization may not receive a grant of more than \$1.0 million for a single project in a fiscal year.

Fiscal 2024 was the first year of funding, and Commerce has awarded two rounds of grants through this program: 14 grants totaling \$3 million in fiscal 2024; and 13 grants totaling \$3 million in fiscal 2025. Grant amounts have been between \$50,000 and \$450,000. A list of grantees is included in **Appendix 1**.

Applications are scored by outside reviewers using a rubric developed by MSAC. Commerce reports that interest in the program has been high; the program received a total of 53 eligible applications requesting approximately \$9 million in fiscal 2024 and 51 eligible applications requesting \$13.3 million in fiscal 2025. Grantees have two years to obligate the funds and must submit a report at the end of the performance period. Although fiscal 2024 was the first year of funding for MSAC capital grants, MSAC awards operating grants totaling more than \$25 million annually.

While the funding mandate for this program ends with fiscal 2029, the 2025 CIP includes \$3 million in planned funding for fiscal 2030, past the end of the funding mandate. As grantees complete their funding cycles and submit reports, the Department of Legislative Services recommends that Commerce continue to track the outcomes and effectiveness of the program to aid in determining whether funding should continue beyond the mandated funding period.
