## **Elections, State Board of**

Emergency Regulation DLS Control No. 20-094 Board of Elections: Early Voting:

Early Voting Centers: COMAR 33.17.02.01 - .02

According to the board, the proposed emergency changes allow a local board to establish a new early voting center if the number of active, registered voters increased in an amount that would have crossed the threshold for a new early voting center in the time since the number of early voting centers was determined (either months prior to the primary election). This issue was brought to the State Board at its July 23, 2020 meeting by a local board of elections, and was adopted by the State Board at its August 5, 2020 meeting. Prior to adopting these proposed emergency regulations, the members of the board first passed a motion to suspend the requirements of EL § 10-301.1(c), which requires each early voting center to be designated "no later than 6 months before a primary election." The board has the authority to do this under the Governor's emergency delegation of suspension authority to agencies with regard to deadlines, timeframes, etc., in the statutes they administer, as outlined in the Governor's Emergency Order dated June 19, 2020. As this was not brought to the State Board until July, there is not enough time to adopt these regulations under the normal promulgation process.

According to the board, the regulations make changes for the November 3, 2020, general election relating to the training of election judges, the canvass of votes, the return of voted absentee ballots, and the operation of voting centers. Most of these emergency regulations are identical to emergency regulations that were in effect for the June 2, 2020, primary election.

Emergency Regulation DLS Control No. 20-099 Board of Elections: Early Voting:

**Early Voting Centers:** COMAR 33.17.02.02

According to the board, these changes are necessary to allow the local boards of elections to change previously approved early voting centers or add additional early voting centers. The

proposed emergency changes allow a local board to change the location of or establish a new early voting center if: (1) a previously approved center is no longer available; (2) a local board determines that there is a more suitable location; and (3) a local board approves an early voting center authorized under Election Law Article, §10-301.1(b)(7). Due to the short time before early voting, the State Board of Elections adopted these regulations as an emergency measure.

According to the office, the purpose of this action is to update and rename a regulation dealing with price filings and containers of alcoholic beverages for sale.

#### **Natural Resources, Department of**

Fishing in Nontidal Waters: COMAR 08.02.11.01, .03, and .04

According to the department, the proposed action prohibits the possession of brook trout while fishing in nontidal waters of the State located east of Interstate 81. All brook trout caught from waters east of Interstate 81 (I-81) must be released. The proposed action also prohibits the possession of brook trout in nontidal waters of the State that are designated as a put-and-take area. All brook trout caught from a put-and-take trout fishing area must be released. The purpose of this action is to eliminate the harvest of adult brook trout in Maryland's most pressured waters and stressed populations. The proposed action also reorganizes sections for clarity, corrects references, and removes duplicate information.

### **Labor, Maryland Department of**

According to the department, the regulation specifies the form which a mobile home retailer must use to provide a certain written statement to a prospective consumer borrower.

According to the department, we currently have a Proposed Regulation in motion (New Regulation 09.03.10.05: a link to a one page disclosure statement). Pursuant to Senate Bill 155 from last year's Session, Enacted under Article II, Section 17(c) of the Maryland Constitution - Chapter 49, said disclosure statement is mandated to be on a form prescribed by the Commissioner by Regulation. However, the provisions of that new law have an effective date of October 1, 2020, and we now believe the adoption date for the aforementioned Proposed Regulation will fall beyond that date.

According to the department, the purpose of this action is to restrict the use of shock wave therapy on a horse during training by not allowing a horse to work out for at least 10 days after treatment. This proposal also codifies the prohibition of Lasix being administered to a 2 year old thoroughbred horse and any thoroughbred horse that participates at a graded stakes race within 48 hours of its race.

Proposed Regulation DLS Control No. 20-101 Maryland Department of Labor: Racing Commission:

**Thoroughbred Rules:** COMAR 09.10.01.57

According to the department, the purpose of this action is to require a trainer and assistant trainer of horses to complete four hours of continuing education each calendar year to remain eligible to renew their license.

#### **Insurance Administration, Maryland**

According to the administration, the regulation requires a managing general agent to maintain and obtain a certain fidelity bond and a certain errors and omissions policy for the protection of the insurer and policyholder.

According to the administration, these regulations extend the applicability of Chapter .02 to certain pharmacy benefits managers. Additionally, these regulations authorize the bulletin issued by the Commissioner during a state of emergency to waive certain cost sharing requirements and make other changes related to health carrier coverage and handling of claims related to the diagnosis, testing, and treatment of a specified illness, including vaccination for the illness.

Notices of Cancellation, Nonrenewal, Premium Increase, and Reduction in Coverage: COMAR 31.08.03.04, .05, .07, and .08

According to the administration, the purpose of this action is to amend regulations .04, .05, .07, and .08 under COMAR 31.08.03 Notices of Cancellation, Nonrenewal, Premium Increase, and Reduction in Coverage. During the 2020 General Assembly Legislative session, Senate Bill 97(SB 97) was passed, which amended § 27-613 and § 27-614 of the Insurance Article. See Md. Laws 2020, Ch. 523. Chapter 523 permits consumers to electronically file a protest or request a hearing of premium increase via the Administration's consumer complaint portal in response to notices of auto premium increases, non-renewals, and cancellation. These regulations implement those requirements.
