## **Elections, State Board of**

Proposed Regulation DLS Control No. 21-134 Board of Elections: Voter Registration:

Processing VRAs and Other Requests: COMAR 33.05.04.04

According to the board, the purpose of this action is to:

- update the regulations to reflect current practice that online voter registration and other electronic transactions require digitized signatures from MVA; and
- incorporate the new requirement that a Common Access Card (CAC) signature can be used to sign the Federal Post Card Application, a federal form for military and overseas voters to register to vote, update an existing registration, and request a mail-in ballot.

According to the department, the purpose of this action is to amend COMAR 26.12.01.01, Incorporation by Reference, to incorporate Supplement 31, to Adopt the Nuclear Regulatory Commission (NRC) Regulations RATS 2018-1 and 2018-2 amendments including:

- incorporate RATS 2018-1 Medical Use of Byproduct Material Medical Event Definitions, Training and Experience, and Clarifying Amendments 10 CFR Parts 30, 32, 35; and
- make minor corrections consistent with RATS 2018-2.

According to the department, the purpose of this action is to amend Regulations COMAR 14.33.01 and COMAR 14.33.02 to be in accordance with Ch. 632 of 2018, requiring the adoption of new nonvisual access procurement standards that:

- provide an individual with disabilities with nonvisual access in a way that is fully and
  equally accessible to and independently usable by the individual with disabilities so that
  the individual is able to acquire the same information, engage in the same interactions, and
  enjoy the same services as users without disabilities, with substantially equivalent ease of
  use; and
- are consistent with the standards of § 508 of the Federal Rehabilitation Act of 1973.

- update requirements for inactive status and reinstatement;
- for out-of-state applicants, add requirements for waiver of examination, equivalent education, waiver of courses, and equivalent experience;
- add clarifying language to supervisor and supervisee regulations; and
- remove obsolete dates under the Supervisor Qualifications regulation.

- ensure that a chiropractic assistant displays their registration in a conspicuous place where the individual practices;
- revise the names for Regulations .10 and .11 for clarity;
- replace the term "chiropractic radiologic technologist" with "chiropractic assistant with X-ray privileges" to be more specific and accurate;
- amend the number of various number of X-ray studies to make them more workable and less onerous;
- clarify language regarding the scope of practice for dry needling;
- clarify the minimum education required for dry needling; and
- remove language that requires continuing education courses since they do not presently exist.

**Investment Adviser Regulations:** COMAR 02.02.05.14

According to the office, the purpose of this action is to amend existing Regulation .14 to require that registered investment adviser representatives annually complete twelve credit hours of continuing education, including three hours of ethics, to maintain their investment adviser representative registrations with the State. Investment adviser representatives are required to ensure that their continuing education credits are reported to the Securities Commissioner. The amendment sets forth the consequences of failing to complete or report to the Securities Division an investment adviser representative's continuing education. The amendment further sets out potential exemptions/substitutions/ equivalents from the continuing education requirements for investment adviser representatives that receive continuing education credits in their capacities as broker-dealer agents of Financial Industry Regulatory Authority ("FINRA") members or through an accepted continuing education course program of a credentialing organization of a recognized credential held by the investment adviser representative. Regulation .14 also is being amended to require that persons successfully pass the investment examination rather than successfully pass the investment examination with a score or 70 or greater, and to eliminate a designation that exempts an individual from having to take and successfully pass the investment adviser examination, because the designation no longer exists. This action also amends Regulation .11 to remove the exemption from investment adviser representative registration for persons associated with investment advisers that are sole proprietorships or sole proprietorship equivalents. Finally, this action amends Regulation .01 to correct an incorrect cross reference in the definitional section.

#### Retirement and Pension System, State

According to the State Retirement Agency, the purpose of this action is to repeal and replace COMAR 22.01.11, concerning reemployment of retirees of the State Retirement and Pension System by participating employers of the System, to reflect statutory changes that have occurred over the last 10 years and to better reflect the agency's administration. COMAR 22.01.11 has not been amended since 2010. Since that time, several statutes governing reemployment of retirees have been enacted. For example, State Personnel and Pensions Article, § 23-407 alone underwent amendment every year between 2011 and 2020, inclusive. Accordingly, the

State Retirement Agency believes COMAR 22.01.11 requires a complete overhaul, which the Agency is proposing to accomplish by repealing the prior chapter and replacing it with the extensively revised proposed new chapter.
