According to the department, the purpose of this action is to adopt new regulations for Corporate Diversity.

According to the department, the purpose of this action is to remove the oyster harvest reserve area regulations and the designation of the only two areas classified as harvest reserve areas. Harvest reserve areas (HRAs) are a management tool created in statute that the department no longer needs.

According to the Secretary, the purpose of this action is to update regulations to conform to current procedures and practices followed by the Secretary of State in the administration of the Maryland Solicitations Act. This action clarifies the definition of bona fide religious organizations and adds a definition for exempt charitable organizations. This action also requires charitable organizations to identify in each annual registration or fundraising notice the names and alternative names used in the solicitation of charitable contributions. This action sets forth when the Secretary of State is required to notify charitable organizations of annual filing requirements and includes requirements for charitable organizations who submit incomplete forms. This action clarifies the

timelines for organizations who are delinquent in their annual filing requirements to request additional time, and makes certain technical changes.
