Elections, State Board of

Proposed Regulations DLS Control No. 24-014 Board of Elections: Inspection and Copying of Public Records: In General: COMAR 33.04.01.02 and .07 Confidentiality of Certain Information: COMAR 33.04.02.01 – .03

According to the board, the purpose of this action is to (1) formally adopt a definition of "sociological information" and to protect the sensitive personal information of its voters. (2) amend and clarify confidentiality regulation

Assessments and Taxation, Department of

Proposed Regulation DLS Control No. 23-315 Department of Assessments and Taxation: Assessment Administration: Appeal Hearings: COMAR 18.01.02.03

According to the department, this regulation requires that a property tax appeal filed by a representative on behalf of a property owner or taxpayer must be authorized by the property owner or taxpayer.

Proposed Regulation DLS Control No. 23-317 Department of Assessments and Taxation: Exemptions: Disabled Veteran, Surviving Spouse, Disabled Active Duty Service Member: COMAR 18.06.03.01

According to the department, this regulation defines "legal residence" to mean "principal residence" for purposes of the property tax exemption for the dwelling house of a disabled veteran, surviving spouse, or disabled active duty service member.

Housing and Community Development, Department of

Proposed Regulations DLS Control No. 23-329 Department of Housing and Community Development: Revitalization Programs: Business Façade Improvement Program: COMAR 05.20.06.01 – .09

According to the department, the regulations establish policies and procedures related to the Business Façade Improvement Program in the Department of Housing and Community Development, as established by Chapter 437 of 2023.

Department of Human Services

Emergency Regulation DLS Control No. 23-355 Department of Human Services: Social Services Administration Private Child Placement Agencies: License for Private Child Placement Agencies: COMAR 07.05.01.14

According to the department, this regulation alters the educational requirements for child placement workers in private child placement agencies.

Natural Resources, Department of

Proposed Regulation DLS Control No. 24-013 Department of Natural Resources: Boating–Speed Limits and Operation of Vessels: Severn River Vessel Management Area: COMAR 08.18.24.01

According to the department, the purpose of this action is to establish a 6-knot effective at all times speed limit for an area extending for approximately 175 yards into the Severn River from each side of the yard patrol pier and quay wall construction project at the Naval Support Activity in Annapolis, Maryland. This regulation will be in effect through October 15, 2025. The proposed action is required to ensure public safety and protect human life. Without an established speed limit, the construction zone poses safety threats for all waterway users, employees, and contractors.

Proposed Regulation DLS Control No. 24-020 Department of Natural Resources: Fisheries Service: Fish: COMAR 08.02.05.10

According to the department, the purpose of this action is to take the recreational rules for bluefish out of regulation and to establish the season, size, and catch limit on an annual basis by public notice. There are currently rules established in regulation that may be modified by public notice. This leads to potential confusion because the rule in the public notice does not match the rule in the regulation. While the public notice effectively overrules the regulation, it may still not be fully clear to affected individuals. The regulation also modifies the public notice authority to no longer require publication in a newspaper. All of the Department's public notices are posted on

the Fishing Public Notice page and emailed to the Department's email listserv. Most notices are also posted on the Department's social media pages.

Proposed Regulation DLS Control No. 24-022 Department of Natural Resources: Fisheries Service: Yellow Perch: COMAR 08.02.21.03

According to the department, the purpose of this action is to modify the commercial yellow perch season to start a month earlier than the current regulation establishes. The fishery has been opened December 1 by public notice for several years to allow for fish potters, and others, to harvest yellow perch against the commercial quota. This has been beneficial to commercial yellow perch permit holders, but has not created any overages in the yellow perch quota.

Planning, Department of

Proposed Regulations DLS Control No. 24-004 Department of Planning: Historical and Cultural Programs: Maryland Historical Trust African American Heritage Preservation Grant Program: COMAR 34.04.09.06, .08, and .09

According to the department, the regulations amend the Maryland Historical Trust African American Heritage Preservation Program to reflect Chapter 29 of 2022 by eliminating the match requirement for grant applicants and capping grant amounts at \$500,000.

Environment, Department of the

Proposed Regulations DLS Control No. 24-006 Department of the Environment: Regulation of Water Supply, Sewage Disposal, and Solid Waste: Quality of Drinking Water in Maryland: COMAR 26.04.01.01, .01-1, .20, and .37

According to the department, the purpose of this action is to clarify and formalize procedures. Current MDE regulations in COMAR 26.04.01.20B [Tier 1 Public Notices] do not explicitly include outages, flooded wells or flooded springs as Tier 1 public notices. However, these issues occur in water systems regularly and are a risk to public health. This proposed regulation describes actions that must be taken during an outage or flooded well/spring incident. This proposed action and an upcoming guidance manual (not cited in the regulation) will provide clear instructions for water systems to: issue a BWA for an Outage or flooded well/spring (when and how); notify MDE that a BWA has been issued; use relevant standards that should be followed for disinfection during an outage, flooded wells and flooded springs; monitor water quality by

sampling prior to lifting a BWA; lift a BWA; notify MDE that a BWA has been lifted; and maintain records for outages, a flooded well/spring, and any BWA.

Proposed Regulation DLS Control No. 24-009 Department of the Environment: Radiation Management: Radiation Protection: COMAR 26.12.01.01

According to the department, the purpose of this action is to amend COMAR 26.12.01.01 Incorporation by Reference, to incorporate Supplement 34, with the following:1. Remove section C.43 (h) on page C53-32. Correct the phrase from "master material license" to "master material licensee." In section G.50 (3) on page G15-1;3. Correct the title "American Council on Pharmaceutical Education (ACPE)" to: "Accreditation Council for Pharmacy Education (ACPE) (previously named the American Council on Pharmaceutical Education)."In section G.55 (a)(1) on page G17;4. Correct the phrase "or a permit issued by a Commission master material license of broad scope on or before October 24, 2005," to "or a permit issued in accordance with a Commission master material broad scope license on or before October 24, 2005." In section G.57 (b)(2) on page G19

Proposed Regulation DLS Control No. 24-015 Department of the Environment: Air Quality: Permits, Approvals, and Registration – Title V Permits: COMAR 26.11.03.24

According to the department, the purpose of this action is to repeal Regulation .24 from COMAR 26.11.03 Permits, Approvals, and Registration – Title V Permits. This action will not be submitted to the U.S. Environmental Protection Agency (EPA) for approval as part of Maryland's State Implementation Plan.

Transportation, Department of

Proposed Regulations DLS Control No. 23-326 Department of Transportation: Motor Vehicle Administration – Motorcycle Safety Program: Motorcycle Safety Training Centers: COMAR 11.20.01.01, 2-1, .03 – .18, and .20 - .33

According to the department, these regulations make numerous changes to the Motorcycle Safety Program administered by the Maryland Department of Transportation Motor Vehicle Administration (MVA), including alterations to requirements for operators of independent training centers, independent training center facilities, program instructors, and students.

According to the department, these regulations (1) repeal existing chapters regarding the licensing of vehicle inspection stations and the registration of inspection mechanics; (2) propose new chapters removing unnecessary and obsolete language; (3) update references and address changes in automotive standards and emerging technologies; and (4) incorporate current policy and procedures.

Children, Office for

Proposed Regulations DLS Control No. 24-002 Independent Agencies: Office for Children: Rate Setting for Child Care Providers: COMAR 14.31.04.01 – .10

According to the office, the purpose of this action is to facilitate the establishment of classes of direct care and clinical care, the determination of rates for Residential Child Care (RCC) programs based on such classes, and an updated rate setting methodology. The revisions apply to residential child care services licensed by the Department of Human Services, Department of Juvenile Services, Maryland Department of Health, and any State Department.

According to the department, this emergency action is necessary to ensure that revised regulations replace the emergency regulations that took effect July 1, 2023.

Proposed Regulations DLS Control No. 24-007 Independent Agencies: Commission on Criminal Sentencing Policy: General Regulations: COMAR 14.22.01.10 and .12 Criminal Offenses and Seriousness Categories: COMAR 14.22.02.02

According to the commission, the purpose of this action is to modify Regulations .10 and .12 under COMAR 14.22.01 General Regulations and Regulation .02 under COMAR 14.22.02 Criminal Offenses and Seriousness Categories to replace references to "adjudication of guilt" with "adjudication", "convicted offense" with "offense", and "conviction" with "adjudication" or "offense" in instances where the intended meaning of "conviction" includes probation before judgement (PBJ) pursuant to either CP, § 6-220(b) or CP, § 6-220(c). Additionally, the purpose of this action is to modify the table of seriousness categories (guidelines offense table) in Regulation .02 under COMAR 14.22.02 Criminal Offenses and Seriousness Categories to include several missing CJIS Codes.

According to the administration, the purpose of this action is to repeal regulations related to programs that are no longer administered by the Administration.

According to the board, these regulations repeal and replace the current regulations that pertain to the State Higher Education Labor Relations Board. The regulations establish a new regulatory framework under the Public Employee Relations Board and provides new definitions and clarifies procedures, filing requirements, and jurisdictional issues for the newly established board.

Proposed Regulations DLS Control No. 24-003 Independent Agencies: Interagency Commission on School Construction: Administration of the Public School Construction Program: COMAR 14.39.02.01 – .22

According to the agency, the purpose of this action is to incorporate by reference the adopted Gross Area Baselines and amend State Rated Capacity calculation requirements for certain physical education and gymnasium spaces.

Proposed Regulation DLS Control No. 24-010 Independent Agencies: Maryland Technology Development Corporation: Investment Programs: COMAR 14.04.02.03

According to the commission, the purpose of this action is to update the regulations to conform to Ch. 391, Acts of 2022, by amending the Maryland Technology Development Corporation's ("TEDCO") Investment Philosophy and Types of Qualified Business to exclude all investments under the Maryland Equity Investment Fund ("MEIF") from the "early-stage business" definition provided in COMAR 14.04.01.01, which is generally applicable to new TEDCO investments. This amendment will broaden the scope of eligibility requirements for investments by MEIF, will enable later-stage venture and private equity companies to apply for an MEIF investment, and will better align MEIF investments with the investment policy of the State Retirement and Pension System ("SRPS").

Maryland Department of Health

Proposed Regulations DLS Control No. 23-316 Maryland Department of Health: Board of Occupational Therapy Practice: Dry Needling: COMAR 10.46.09.01 – .04

According to the department, these regulations create education, training, and practice requirements for the performance of dry needling by occupational therapists.

Proposed Regulations DLS Control No. 23-318 Maryland Department of Health: Board of Pharmacy: Pharmacist Prescribing of a Nicotine Replacement Therapy Medication: COMAR 10.34.42.01 – .03

According to the department, the regulations specify the conditions under which a pharmacist may prescribe and dispense nicotine replacement therapy medication, establish standard procedures that a pharmacist must use to prescribe and dispense the medication, and establish procedures for a pharmacist to refer a patient to a primary care practitioner for treatment.

Proposed Regulations DLS Control No. 23-319 Maryland Department of Health: Sanitation: Public Swimming Pools and Spas: COMAR 10.17.01.01 – .06-1, .07 – 28-1, .29 – .55

According to the department, these regulations reorganize and restate existing regulations to provide clarity regarding the application of standards for the operation and construction of

public swimming pools and public spas. These regulations also incorporate by reference the most recent version of the American National Standard for Public Swimming Pools (ANSI/APSP/ICC).

Proposed Regulations DLS Control No. 23-320 Maryland Department of Health: Medical Care Programs: Maryland Children's Health Program: COMAR 10.09.11.11 Medical Assistance Eligibility: COMAR 10.09.24.02, .07, and .12 Maryland Children's Health Program (MCHP) Premium: COMAR 10.09.43.10 and .13

According to the department, these regulations (1) implement continuous eligibility for Maryland Medical Assistance Program (Medicaid) and Maryland Children's Health Program (MCHP) enrollees younger than age 19 as required by the federal Consolidated Appropriations Act, 2023 (CAA); (2) prevent disenrollment of children from MCHP Premium for nonpayment of premiums during their period of continuous eligibility; and (3) implement an Express Lane Eligibility (ELE) program to expedite enrollment of individuals into Medicaid and MCHP based on eligibility findings by the Supplemental Nutrition Assistance Program (SNAP) as required by Chapters 282 and 283 of 2023.

Proposed Regulations DLS Control No. 23-321 Maryland Department of Health: Food: Food and Drink Processing and Transportation: COMAR 10.15.04.01, .02, .04 – .11, and .14 – .25

According to the department, the regulations revise COMAR 10.15.04 Food and Drink Processing and Transportation, to align the regulations with current practices, national guidelines, and federal regulations.

Proposed Regulations DLS Control No. 23-322 Maryland Department of Health: Hospitals: Assisted Living Programs: COMAR 10.07.14.01 – .65

According to the department, the regulations establish the minimum standards, requirements, and procedures for the licensure and operations of assisted living programs in the State.

Proposed Regulations DLS Control No. 23-323 Maryland Department of Health: Medical Care Programs: Pharmacists: COMAR 10.09.21.02 – .06

According to the department, these regulations authorize pharmacists to be reimbursed under the Maryland Medical Assistance Program (Medicaid) for services rendered within the pharmacists' lawful scope of practice. The regulations also establish reimbursement requirements for medication therapy management services provided by pharmacists under the program.

Proposed Regulations DLS Control No. 23-324 Maryland Department of Health: Food: Production, Processing, Transportation, Storage, and Distribution of Grade A Milk: COMAR 10.15.06.02, .03, .05, .10, and .11

According to the department, the regulations authorize Maryland dairy producers to extend the duration between pickups from dairy farms. Additionally, the regulations enable processing facilities to legally produce milk and dairy products with an extended shelf life through ultrapasteurization.

Proposed Regulations DLS Control No. 23-325 Maryland Department of Health: Medical Care Programs: Nursing Facility Services: COMAR 10.09.10.07 and .08

According to the department, these regulations update prospective rates for nursing facility services for fiscal year 2024.

Proposed Regulations DLS Control No. 23-327 Maryland Department of Health: Medical Care Programs: Collaborative Care Model: COMAR 10.09.64.01 – .09 Maryland HealthChoice Program: Definitions: COMAR 10.67.01.01 Benefits: COMAR 10.67.06.26

According to the department, these regulations implement a statewide Collaborative Care Model within the Medical Assistance Program (Program).

Proposed Regulations DLS Control No. 23-328 Maryland Department of Health: Human Immunodeficiency Virus (HIV) Infection and Aquired Immunodeficiency Syndrome (AIDS): Maryland AIDS Drug Assistance Program: Eligibility: COMAR 10.18.05.01 – .03 Maryland AIDS Drug Assistance Program: Services: COMAR 10.18.06.05, .08, and .10

According to the department, the regulations alter the Maryland AIDS Drug Assistance Program (MADAP) by repealing the requirements for (1) use of a specified form for verification

of HIV status by a health care practitioner (2) reverification of eligibility every six months, and (3) use of a specified form for preauthorization for specified pharmacy services.

Proposed Regulations DLS Control No. 23-332 Maryland Department of Health: Dangerous Devices and Substances: Controlled Dangerous Substances: COMAR 10.19.03.01 – .20

According to the department, the purpose of this action is to evaluate COMAR 10.19.03 for the purpose of satisfying the requirement of State Government Article, 10-130 - 10-139, Annotated Code of Maryland, to update the regulations per statutory changes, and to reorganize and clarify existing language.

Proposed Regulations DLS Control No. 23-333 Maryland Department of Health: Community-Based Behavioral Health Programs and Services: Outpatient Civil Commitment (OCC) Pilot Program: COMAR 10.63.07.02, .03, .05, and .11

According to the department, the regulations expand eligibility for participation in the Outpatient Civil Commitment (OCC) Pilot Program in the Behavioral Health Administration (BHA) by increasing the eligible residential area, expanding the types of facilities at which an individual may have had a recent admission, and allowing participation for individuals who have had psychiatric emergency department visits. The regulations also expedite the enrollment process by removing requirements to have an administrative law judge (ALJ) participate in a settlement conference.

Proposed Regulations DLS Control No. 23-334 Maryland Department of Health: Medical Care Programs: Programs of All-Inclusive Care for the Elderly (PACE): COMAR 10.09.44.01, .15, .21, and .23

According to the department, these regulations: (1) list the annual provider rates to be paid to Program of All Inclusive Health for the Elderly (PACE) providers pursuant to Medicaid's State Plan Amendment; (2) add reporting requirements for PACE providers; and (3) authorize the department to impose sanctions or suspend a PACE provider's ability to enroll new participants for failure to comply with applicable State and federal laws or regulations.

> Proposed Regulations DLS Control No. 23-335 Maryland Department of Health: Medical Care Programs: Home and Community-Based Services Waiver for Children with Autism Spectrum Disorder: COMAR 10.09.56.02, .04, .10, .14, .14-1, .15 – .17, .19, .21, and .22

According to the department, these regulations update the requirements for participant and provider eligibility, covered services, and reimbursement under the Home- and Community-Based Services Waiver for Children with Autism Spectrum Disorder.

Proposed Regulation DLS Control No. 23-337 Maryland Department of Health: Postmortem Examiners Commission: Medical Examiner Cases: COMAR 10.35.01.20

According to the department, this regulation increases body transportation reimbursement fees and the minimum payment per transport to the Office of the Chief Medical Examiner (office).

Proposed Regulations DLS Control No. 23-339 Maryland Department of Health: Mental Hygiene Regulations: Maryland Mental Health and Substance Use Disorder Registry and Referral System: COMAR 10.21.31.01 – .06

According to the department, these regulations implement the Maryland Mental Health and Substance Use Disorder Registry and Referral System and require hospitals and freestanding medical facilities to comply with certain requirements.
