Proposed Regulations DLS Control No. 25-191

Department of Natural Resources: Office of the Secretary:

Coast Smart Council: COMAR 08.01.11.01 – .07

According to the department, the purpose of this action is to establish the applicability of and process for complying with the Coast Smart Construction Program requirements and define essential terms used throughout the program. This regulation would require the use of the screening form for all eligible projects to assess overall project coastal flood resilience and the use of the map to determine project eligibility. Both items are currently utilized as part of the program but not required in statute. Waivers and exemptions are processes both enabled in statute, but this regulation establishes definitions as well as the process and justifications for granting them. The final part of the regulation establishes reporting requirements for the program and supporting documents.

The enabling statute of the Coast Smart Council charges the Council with establishing standards and processes. These standards and processes are laid out in the Coast Smart Construction Program Document but will be further clarified with the adoption of these regulations to spell out applicability, definitions, processes, and expectations for projects that are required to comply.

Fish: COMAR 08.02.05.23, .26, and .27 **Sharks:** COMAR 08.02.22.02 and .03

According to the department, the purpose of this action is to (1) remove the State reporting and tagging requirements for bluefin tuna, white marlin, blue marlin, roundscale spearfish, sailfish, swordfish, and sharks; (2) transition the reporting of highly migratory species to a federal reporting program; and (3) update the creel limit for oceanic whitetip and shortfin make sharks.

The proposed changes, (1) provide consistency with NOAA Fisheries requirements for HMS permit holders; (2) provide consistency with neighboring states; (3) remove duplicate reporting requirements, (4) comply with the Atlantic States Marine Fisheries Commission's requirements for sharks; and (5) are expected to improve compliance because anglers will have electronic reporting options.

According to the department, the purpose of this action is to raise the limit on sales of covered products of On-Farm Home Food Plant license-holders, while simultaneously excluding certain products from contributing to the cap. The proposal also clarifies that a valid Mobile Farmers Market Unit license allows activities authorized by the license without requiring additional licenses or permits from a local health department.

According to the department, the purpose of this action is to adopt regulations altering the defined term "auto–injectable epinephrine" to be "emergency use epinephrine" to include non-needle epinephrine delivery products approved by the Food and Drug Administration (FDA) for youth camps and eligible institutions of higher education pursuant to HB 420 and SB 459 (2025).

According to the department, the purpose of this action is to update the Incorporation by Reference regulation governing milk intended for human consumption. This action updates the incorporation of the US Food and Drug Administration's "Pasteurized Milk Ordinance" from the previous 2019 iteration to the most recent 2023 iteration, released in February 2025.

According to the department, the purpose of this action is to update COMAR 10.18.06.02 which establishes the license requirements for pharmacy and provider participation in the Maryland AIDS Drug Assistance Program (MADAP). The amendments to COMAR 10.18.06.02 will remove the reference to COMAR 10.09.03.02 and create new license requirements. This proposal will ensure MADAP is in compliance with their program requirements. Additionally, amendments acknowledge expanded medical care options, and enhance treatment opportunities for program participants, thus reducing potential barriers to care.

According to the department, the purpose of this action is to detail the requirements and procedures for private commercially and self insured insurance plans that offer equivalent or better benefits than the State plan, including temporary provisions applicable to the beginning of the program.

According to the department, the purpose of this action is to establish the dispute resolution processes for the FAMLI program. These regulations also provide processes for employers to dispute assessed liabilities.

According to the department, the purpose of this action is to implement the expanded definition of esthetic services enacted by the General Assembly in SB1044 in April 2024 by defining specific esthetic services authorized by the legislation.
